TO BE ELECTED AS AREA REPRESENTATIVES, MEMBERS MUST HAVE TWO YEARS IN FELLOWSHIP,
ONE YEAR OF CONTINUED ABSTINENCE, ONE YEAR OF SERVICE ABOVE THE MEETING LEVEL,
REFLECT THE IDEALS OF CEA-HOW BY THEIR CONDUCT AND ACTION IN ORDER TO SERVE AS ROLE
MODELS TO OTHERS. MUST HAVE GIVEN AWAY A 4TH STEP INVENTORY, MUST SHARE AN ACTIVE
RELATIONSHIP WITH THEIR SPONSOR, MUST DECLARE THEMSELVES AS PRACTICING THE 12 STEPS AND
TRADITIONS, THE CEA-HOW CONCEPT, AND THE 7 TOOLS TO THE BEST OF THEIR ABILITY AND BE
COMMITTED TO THE 12 TRADITIONS AND CONCEPTS OF CEA-HOW.

AREA REPRESENTATIVES MUST AFFIRM THEIR DECLARATION BY SIGNING A STATEMENT AGREEING TO
